#### Co-chair report

From the email Vic sent on 1 May 2018

It's been another very busy year for Don and I as co-chairs with a new government, new policies, new trade agreements, the D5 (now D7) leaders to engage with, and many submissions on consultation from taxation to procurement rules.

We have a great AGM event planned with John Edwards the Privacy Commissioner coming

for a Fireside Chat with Miki - in the same style as he chatted with Vic Crone late last year. We are also looking forward to meeting our many new members at the AGM event.

As you all know NZRise runs on the smell of an oily rag, our membership fees are our only funding, with all time donated other than the important coordination role of our Community Manager Caitlin. Large events like the annual Procurement Workshop with Government take up the majority of our available funds along with small sponsorship contributions to industry events, membership of Business NZ and support for ITP Connect.

Don and I as Co-chairs spend anything from 5 - 20 hours per week on NZRise related activities. Don has this year set a precedent in NZRise by being paid a stipend by for his involvement in the National Library Increasingly Digital initiative, I will try to apply the same principle (we are donating our time on behalf of our community) to initiatives I am involved with as NZRise Co-Chair as well - Digital Skills Forum, Digital Technology Curriculum etc.

To be very frank we have both struggled with the workload while running our own businesses and found ourselves at a crossroads when considering re-election as Co-Chairs this year. On balance we feel we are well placed to continue to gain traction with the Labour Government, with whom we have held long standing relationships while they were in opposition, so will be looking to address succession planning during the course of this coming year and both look to step aside as Co-Chairs in 2019.

To this end, we will be seeking 2 additional board members to help further share the workload and from the new board will be looking to appoint understudies for Don and myself.

The Co-Chairs roles are very diverse, require the ability to work on challenging political, policy and economic issues while representing the membership and our collective interests. That said these roles create opportunities for direct engagement with Ministers, Government and large business CEO's, other industry groups, industry leaders and profile raising opportunities via media commentary. So there is reward for the time and mindshare.

I would like to thank our board members - Breccan McLeod-Lundy, Thomas Mitchell, Shane Ross, Larry Lepper and Noel Reid for your input and support during this busy year. I would also like to thank others who have run events and consultation processes especially Jason Ryan on the procurement front.

Larry has provided us with great services as a Chartered Accountant in the Treasurer role, he has offered to stay on the board and provide an opportunity for someone else gain valuable Treasurer experience - thank you Larry.

Congratulated Victoria and Dave on their appointments to the Digital Economy Digital Inclusion Ministerial Advisory Group. Acknowledged the work they will be doing will require additional voices from NZRise to support the DEDIMAG.

In answer to questions from the floor Don advised we need support with submissions (eg: Privacy Act, R&D) to bills that are of interest to NZRise, there are an increasing number of those.
